

# ONLINE PRIVACY POLICY AGREEMENT

## **Why We Collect Information and For How Long**

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

SEE LIFE IN PRINT may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. SEE LIFE IN PRINT and its subsidiaries may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

## **Notice to European Union Users**

SEE LIFE IN PRINT and Christine Elias's operations are located primarily in the United States. ## **Security**

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal **information**.
